This is a home-based position suiting someone ideally based in the Scottish Highlands, although consideration will be given to candidates based elsewhere in Scotland.

JOB DESCRIPTION

The Rewilding Reachout Coordinator will recruit of a team of 20 young rewilding advocates (NextGen Team) and support the team's learning via developmental weekends and a series of live webinars. The post-holder will support the NextGen Team in guiding the development of a Rewilding Youth Advocacy Strategy and associated resources. The post-holder will be responsible for producing the Youth Advocacy Strategy, managing its implementation, and evaluating outcomes.

- Organise learning events for the NextGen Team
- Support the development of advocacy resources and a Youth Advocacy Strategy
- Support SBP Comms Team in production of advocacy resources
