1. A reservation is made once a booking form, together with a deposit, has been received from you and the booking is confirmed in writing by SCOTLAND: The Big Picture. Provisional bookings can be held for 14 days, pending receipt of a completed booking form. You must provide us with details of any dietary requirements, medical conditions or any other special requirements you have when completing the booking form.

2. Deposits paid are not refundable. The date the balance is payable will be advised by us when we confirm your booking. Unless notice of cancellation is received prior to the balance payment date, balance monies will remain due and payable. Website prices are quoted in UK sterling.

3. SCOTLAND: The Big Picture reserves the right to change the programme or retreat guide due to circumstances beyond its reasonable control. Any significant alterations will be advised to you, and any alterations so made will be of a similar quality to those described on the website.

4. During the retreat, you must behave in a way that is not disruptive, upsetting or dangerous to you or anyone else and you must follow the reasonable requests of the leader.
